AN ORDINANCE AMENDING BELLEWOOD CODIFIED ORDINANCE CHAPTER 1.3.6.3 (ORD. NO. \_\_\_\_, SERIES \_\_\_\_)  
PROVIDING FOR CHANGES TO THE TIME OF PAYMENT FOR COMPENSATION TO CITY COMMISSIONERS

WHEREAS, it is the desire of the Bellewood City Commission, and in the best interest of the City of Bellewood, Kentucky, to utilize the authority granted in KRS 83A.060(3) to amend city ordinances and further to ensure compliance with ordinances in force within the City of Bellewood, and

WHEREAS, City of Bellewood Codified Ordinance Chapter 1.3.6.3 (Ord. No. \_\_\_\_, Series \_\_\_\_ ) should be amended to reflect changes made to the time of payment for compensation to the city commissioners, and the specific section amended is to be herewith set out in full,

NOW THEREFORE BE IT ORDAINED BY THE CITY OF BELLEWOOD:

SECTION 1. City of Bellewood Codified Ordinance Chapter 1.3.6.3 (Ord. No. \_\_\_\_, Series \_\_\_\_ ) is hereby amended to reflect changes made to the time of payment for compensation to the City Commissioners of the City of Bellewood. The specific sections amended are herewith set out in full.

SECTION 1. Compensation. 1.3.6.3: The compensation of each City Commissioner is hereby fixed at \$75.00 per ~~attended monthly meeting~~ [month], commencing with the beginning of the Commissioner's new term, July 2011, or upon joining the Commission. In addition, this amount shall be payable for any special meetings called by the Mayor.

SECTION 2. Severability. The provisions of this ordinance shall be considered severable. If any provisions of this ordinance is found to be invalid, that finding shall not necessarily invalidate the entire ordinance.

SECTION 3. Effective Date. This ordinance shall become effective after passage, approval and publication as required by law.
